Personnel (5) Staff: Jason Hancock	Senator Brown, Senator Maher; Representatives Westra, Hawley, Senator Soholt	Creates the initial draft of interim committee memberships. Reviews all personnel matters relative to legislative staff.
Budget (5) Staff: Annie Mehlhaff	Senator Peters, Representative Carson; Senator Lucas, Representatives Tyler, Latterell	Reviews the budgets of legislative agencies and makes recommendations to the Executive Board.
Space Planning (5) Staff: Jason Hancock	Senator Brown, Senator Heineman; Representatives Hoffman, Tyler, Olson	Reviews issues relative to the use and condition of office space in the Capitol
Legislative Interns (5) Staff: Dave Ortbahn	Representative Westra, Representative Tyler; Representatives Latterell, Olson, Senator Soholt	Oversees the legislative intern program.
Supreme Court Opinions (5) Staff: Amanda Riess	Representative Gosch, Representative Latterell; Representative Hoffman, Senators Heineman, Tieszen	Reviews all court cases (primarily those of the state Supreme Court) in regard to changing legislative intent. Recommends corrective legislation, if necessary.
Legislative Audit (5) Staff: Marty Guindon Denice Houlette	Representative Carson, Senator Maher; Senators Peters, Tieszen, Representative Tyler	Reviews the activities of the Department of Legislative Audit.
Investment Council (5) Staff: Jason Hancock	Senator Maher, Senator Brown; Representatives Westra, Gosch, Hawley	Reviews the activities of the State Investment Council and reviews the salary and bonus for the State Investment Officer.
Code Commission (5) Staff: Doug Decker	Representative Gosch, Representative Hawley; Representatives Hoffman, Olson, Senator Peters	Reviews issues of mutual concern between the Board and Commission. Reviews the budgetary needs of the state's code publication.
Computer Technology (5) Staff: Kevin Kumpf Hilary Carruthers	Senator Lucas, Representative Latterell; Senators Heineman, Soholt, Tieszen	Reviews use of laptop computers and other technology by members of the Legislature.
Operations (5) Staff: Jason Hancock	Senator Tieszen, Representative Westra; Senators Soholt, Heineman, Representative Hawley	Reviews operations of the Legislative Research Council and provides recommendations to the Executive Board.
