1 FOR AN ACT ENTITLED, An Act to add a portion of roadway in Mellette County to the state
2 trunk highway system as a part of Highway 63.

3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

4 Section 1. That § 31-4-173 be amended to read as follows:

5 31-4-173. The state trunk highway system includes the following in Todd, Mellette, Jackson,
6 Haakon, Stanley, Ziebach, Dewey, and Corson counties:

7 (1) From a point on U.S. Highway 18 east of Martin near the center of section five,
8 township thirty-eight north, range thirty-one west, thence northwesterly to a point
9 south of State Highway 44 near the west quarter corner of section two, township forty
10 north, range thirty-three west, thence north via Norris to State Highway 44 west of
11 White River;

12 (2) From a point on State Highway 44 west of White River near the southwest corner of
13 section thirty-six, township forty-two north, range thirty-three west, thence northerly
14 via Belvidere to Interstate Highway 90 near the center of section twenty-nine,
15 township two south, range twenty-four east;



- 1 (3) From a point on Interstate Highway 90 northeast of Belvidere near the southwest
2 corner of section nine, township two south, range twenty-five east, thence north to
3 U.S. Highway 14 in the southwest quarter of section six, township one north, range
4 twenty-five east;
- 5 (4) From a point on U.S. Highway 14 at Kellar's Corner south of the north quarter corner
6 of section twenty-nine, township five north, range twenty-five east, thence north to
7 State Highway 34 near the north quarter corner of section twenty-nine, township five
8 north, range twenty-five east;
- 9 (5) From a point on State Highway 34 west of Kellar's Corner near the southwest corner
10 of section twenty, township five north, range twenty-five east, thence northerly to
11 U.S. Highway 212 west of Eagle Butte near the northwest corner of section thirteen,
12 township twelve north, range twenty-three east;
- 13 (6) From a point on U.S. Highway 212 east of Eagle Butte near the southeast corner of
14 section eleven, township twelve north, range twenty-four east, thence northerly to
15 State Highway 20 west of Timber Lake near the northeast corner of section
16 twenty-four, township seventeen north, range twenty-three east;
- 17 (7) From a point on State Highway 20 south of McLaughlin near the southwest corner
18 of section thirty-three, township eighteen north, range twenty-seven east, thence north
19 via McLaughlin to the North Dakota state line near the northeast corner of section
20 nineteen, township twenty-three north, range twenty-seven east.
