1 FOR AN ACT ENTITLED, An Act to revise the composition of the state trunk highway system.

2 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF SOUTH DAKOTA:

3 Section 1. That § 31-4-173 be amended to read as follows:

4 31-4-173. The state trunk highway system includes the following in Todd, Mellette, Jackson,
5 Haakon, Stanley, Ziebach, Dewey, and Corson counties:

6 (1) From a point on U.S. Highway 18 east of Martin near the center of section five,
7 township thirty-eight north, range thirty-one west, thence northwesterly to a point
8 south of State Highway 44 near the west quarter corner of section two, township forty
9 north, range thirty-three west;

10 (2) From a point on State Highway 44 west of White River near the southwest corner of
11 section thirty-six, township forty-two north, range thirty-three west, thence northerly
12 via Belvidere to Interstate Highway 90 near the center of section twenty-nine,
13 township two south, range twenty-four east;

14 (3) From a point on Interstate Highway 90 northeast of Belvidere near the southwest
15 corner of section nine, township two south, range twenty-five east, thence north to



1 U.S. Highway 14 in the southwest quarter of section six, township one north, range
2 twenty-five east;

3 ~~(4)~~ From a point on U.S. Highway 14 at Kellar's Corner south of the north quarter corner
4 of section twenty-nine, township five north, range twenty-five east, thence north to
5 State Highway 34 near the north quarter corner of section twenty-nine, township five
6 north, range twenty-five east;

7 ~~(5)~~ From a point on State Highway 34 west of Kellar's Corner near the southwest corner
8 of section twenty, township five north, range twenty-five east, thence northerly to
9 U.S. Highway 212 west of Eagle Butte near the northwest corner of section thirteen,
10 township twelve north, range twenty-three east;

11 ~~(6)~~(5) From a point on U.S. Highway 212 east of Eagle Butte near the southeast corner of
12 section eleven, township twelve north, range twenty-four east, thence northerly to
13 State Highway 20 west of Timber Lake near the northeast corner of section
14 twenty-four, township seventeen north, range twenty-three east;

15 ~~(7)~~(6) From a point on State Highway 20 south of McLaughlin near the southwest corner
16 of section thirty-three, township eighteen north, range twenty-seven east, thence north
17 via McLaughlin to the North Dakota state line near the northeast corner of section
18 nineteen, township twenty-three north, range twenty-seven east.
