1 FOR AN ACT ENTITLED, An Act to revise the General Appropriations Act for fiscal year  
2 2013, to provide funding for the increased costs associated with the employee health  
3 insurance and internal service bureaus, and to declare an emergency.

5 Section 42. The state treasurer shall transfer to the tobacco prevention and reduction trust  
6 fund one million dollars (\$1,000,000) from the state general fund.

7 Section 145. That chapter 30 of the 2012 Session Laws be amended by adding thereto a  
8 NEW SECTION to read as follows:

9 Section 43. The state treasurer shall transfer to the cement plant retirement fund two million  
10 dollars (\$2,000,000) from the state general fund.

11 Section 146. That chapter 30 of the 2012 Session Laws be amended by adding thereto a  
12 NEW SECTION to read as follows:

13 Section 44. The state treasurer shall transfer to the state general fund four million one  
14 hundred thirty-three thousand one hundred ninety-two dollars (\$4,133,192) from the tax relief  
15 fund.

16 Section 147. That chapter 30 of the 2012 Session Laws be amended by adding thereto a  
17 NEW SECTION to read as follows:

18 Section 45. The state treasurer shall transfer to the state general fund one million eight  
19 hundred thirty-nine thousand nine hundred ninety dollars (\$1,839,990) from the budgetary  
20 accounting fund.

21 Section 148. That Chapter 30 of 2012 Session Laws be amended by adding thereto a NEW  
22 SECTION to read as follows:

23 Section 46. The state treasurer shall transfer to the employers' investment in South Dakota's  
24 future fund three million six hundred thousand dollars (\$3,600,000) from the state general fund.

1       Section 149. Funds appropriated by this Act which are unspent at the end of fiscal year  
2       2013 shall be carried over to fiscal year 2014.

3       Section 150. This Act is effective June 26, 2013.
