HB 1185* (Deferred from 24th LD) make an appropriation for property and casualty loss coverage, to establish the property and casualty captive insurance company fund for state properties, and to declare an emergency.

HB 1186 (Deferred from 24th LD) revise an appropriation made to the Science and Technology Authority.

- HB 1187* (Deferred from 24th LD) make an appropriation for liability coverage for the South Dakota Building Authority, South Dakota Health and Educational Facilities Authority, South Dakota Housing Development Authority, South Dakota Ellsworth Development Authority, and South Dakota Educational Enhancement Funding Corporation, to establish the liability captive insurance company fund, and to declare an emergency.
- HB 1162 (Deferred from 24th LD) enact the Interstate Insurance Product Regulation Compact.
- HB 1231 (Removed from Consent Calendar; Deferred from 25th LD) authorize the forfeiture of any financial benefit or valuables gained from prostitution or pimping.
- HB 1064* (Deferred from 25th LD) prohibit unlawful self-dealing by state officers and employees.
- HB 1205* (Deferred from 25th LD) provide for the certification by a chief law enforcement officer of the transfer of certain firearms.
- HB 1225* (Deferred from 25th LD) prohibit the unauthorized commercial use of a personality's right of publicity and provide a civil remedy therefor.
- HB 1201 (Deferred from 25th LD) revise certain provisions regarding planning and zoning.
- HB 1166* prohibit the use of tanning devices by minors.
- HB 1153* expand the definition of teleconference to include certain meetings conducted through electronic text colloquy and to require the retention of certain records of text colloquy meetings for public inspection.
- HB 1227 authorize counties to impose sales and use taxes.
- HB 1169 accommodate legislation on medical services.
- HB 1170 accommodate legislation relating to education in South Dakota.
- HB 1171 enhance South Dakota.
- HB 1143 increase the criminal violations that are subject to protection orders.

- SB 75* (Deferred from 25th LD) revise the effective period of the travel permit for certain livestock used for rodeo purposes and to declare an emergency.
- SB 76 (Deferred from 25th LD) extend the length of time a local livestock ownership inspection certificate is valid for transportation.
- SB 93 (Deferred from 25th LD) impose a gross receipts tax on the rental of certain motorcycles in lieu of the excise tax on motor vehicles.
- SB 45* (Deferred from 25th LD) revise certain provisions relating to the sale of unpasteurized raw milk.
- SB 41 (Deferred from 25th LD) revise certain provisions pertaining to commercial driver licensing.
- SB 94 (Deferred from 25th LD) establish a license fee for electric-powered motorcycles.
- SB 118* (Deferred from 25th LD) provide additional transparency for prescription drug plans.
- SB 60* (Deferred from 25th LD) provide newborn screening of inherited and genetic disorders.

SB 63* (Deferred from 25th LD) adopt the Interstate Medical Licensure Compact.
SB 47 make an appropriation from the coordinated natural resources conservation fund to the State Conservation Commission and to declare an emergency.
