HCR 1013* (Consideration of Senate Amendments; SJ 336, 337) Recognizing the positive economic impact sportsmen and sportswomen have in South Dakota.

SECOND READING OF HOUSE BILLS AND JOINT RESOLUTIONS

HB 1127 (Deferred from 22nd LD) revise certain provisions concerning road districts.

HB 1169* (Deferred from 22nd LD) allow a school district to operate an attendance center within another school district.

HB 1116 (Deferred from 22nd LD) authorize municipalities to impose an additional sales and use tax for a limited period of time for a specified use.

HB 1182 (Placed by Motion) increase the state sales tax, the state use tax, the excise tax on farm machinery, and amusement device tax for the purpose of increasing education funding and reducing property taxes, and to declare an emergency.

HB 1206* (Deferred from 24th LD) authorize the use of handguns in the hunting of game birds.

HB 1047* (Deferred from 24th LD) make an appropriation for the payment of extraordinary litigation expenses and to declare an emergency.

HB 1161* (Deferred from 24th LD) provide for and regulate consumer lines of credit and to provide a penalty for certain violations.

- HB 1132* (Deferred from 24th LD) require the submission of sexual assault kits for testing.
- HB 1133* (Deferred from 24th LD) require that a risk assessment is completed and reviewed before the release of a person charged with certain domestic crimes.
- HB 1167* (Deferred from 24th LD) revise certain provisions regarding the use of a suspended imposition of sentence for a misdemeanor and a felony.
- HB 1243* (Deferred from 24th LD) prohibit the unauthorized sharing of certain private images on the internet.
- HB 1198 (Deferred from 24th LD) recognize dyslexia as a learning disability.
- HB 1106* ~~exempt certain trees from requirements related to the removal of vegetation and debris from township road rights-of-way and to extend general immunity from certain civil liability for trees located in the township road right-of-way.~~
revise certain codes and standards regarding wind energy system set back requirements.
- HB 1162* provide for the practice and regulation of midwives.
- HB 1230* ~~apply certain provisions regarding the operation of vehicles on the highways to animal-drawn vehicles.~~
require lights on certain animal-drawn vehicles while operating on a highway.
- HB 1137* revise the distribution of registration fees from noncommercial gross weight vehicles.
- HB 1149* provide authority to establish a special purpose district for recreational purposes.
- HB 1224 authorize the Investment Council to enter into an agreement to allow South Dakota residents to participate in an ABLÉ savings program to support individuals with disabilities.

- SB 52 (Removed from Consent Calendar) establish procedures for reporting federal tax changes for purposes of the bank franchise tax.
- SB 8* (Deferred from 24th LD) revise certain provisions regarding background investigations for prospective employees of the postsecondary technical institutes and to transfer certain funds regarding postsecondary technical credentialing.
- SB 2* (Deferred from 24th LD) revise the distribution of the revenue from the alcoholic beverage fund.
- SB 34 (Deferred from 24th LD) revise certain provisions regarding the chemical testing of commercial drivers.
- SB 120* (Deferred from 24th LD) make an appropriation to reimburse certain family physicians, dentists, physician assistants, and nurse practitioners who have complied with the requirements of the recruitment assistance program and to declare an emergency.
- SB 63* (Deferred from 24th LD) require the development of school safety plans and to require the conduct of school safety drills in accredited schools.
- SB 114 (Deferred from 24th LD) make an appropriation for certain costs related to the commissioning of the USS South Dakota and to declare an emergency.
- SB 53* (Deferred from 24th LD) revise certain provisions concerning the bank franchise tax.
- SB 59 (Deferred from 24th LD) revise certain provisions regarding the application of the special annual road funding levy.

SB 75* establish a grant program for adult community residential services designed to reduce the risk of recidivism, to provide a report to the Legislature, to make an appropriation therefor, and declare an emergency.
