HB 1080 (Deferred from 19th LD) make an appropriation and to transfer certain money to the Bureau of Administration to fund a design study for a potential expansion and upgrade to the State Animal Disease Research and Diagnostic Laboratory and to declare an emergency.

- HB 1161* (Deferred from 26th LD) provide for and regulate consumer lines of credit and to provide a penalty for certain violations.
- HB 1198 (Deferred from 26th LD) recognize dyslexia as a learning disability.
- HB 1143 (Deferred from 26th LD) accommodate legislation on medical services.

- HB 1088* revise and consolidate certain civil forfeiture provisions.
- HB 1134* provide for access to certain property for the purpose of making surveys.

- HB 1146 authorize the Governor to enter agreements with Indian tribes regarding the high school equivalency tests administered on Indian reservations.
- HB 1147 prohibit school districts from using school or athletic team names, mascots, or nicknames that are determined to be racially derogatory or discriminatory.
- HB 1124 prohibit the use of tanning devices by minors.
- HB 1096* ~~provide for the exemption of certain students from the requirement to take certain academic assessment tests.~~
provide for the exemption of certain schools from a tuition limitation applied to some bordering state school districts.
- HB 1220* direct the secretary of education to reinstate scholarship funding under the GEAR UP grant program.
- HB 1218* require certain notice procedures for any revision of municipal ordinances.

- SB 52 (Deferred from 26th LD) establish procedures for reporting federal tax changes for purposes of the bank franchise tax.
- SB 8* (Deferred from 26th LD) revise certain provisions regarding background investigations for prospective employees of the postsecondary technical institutes and to transfer certain funds regarding postsecondary technical credentialing.
- SB 2* (Deferred from 26th LD) revise the distribution of the revenue from the alcoholic beverage fund.
- SB 34 (Deferred from 26th LD) revise certain provisions regarding the chemical testing of commercial drivers.

- SB 120* (Deferred from 26th LD) make an appropriation to reimburse certain family physicians, dentists, physician assistants, and nurse practitioners who have complied with the requirements of the recruitment assistance program and to declare an emergency.
- SB 63* (Deferred from 26th LD) require the development of school safety plans and to require the conduct of school safety drills in accredited schools.
- SB 114 (Deferred from 26th LD) make an appropriation for certain costs related to the commissioning of the USS South Dakota and to declare an emergency.
- SB 53* (Deferred from 26th LD) revise certain provisions concerning the bank franchise tax.
- SB 59 (Deferred from 26th LD) revise certain provisions regarding the application of the special annual road funding levy.
- SB 75* (Deferred from 26th LD) establish a grant program for adult community residential services designed to reduce the risk of recidivism, to provide a report to the Legislature, to make an appropriation therefor, and declare an emergency.
