NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council)

Department of Labor: Division of Labor and Management: (February 4, 2002) intends to amend workers' compensation rules to establish a DRG-based hospital fee schedule for workers' compensation claims, to change the discount for uncategorized claims, to change the reimbursement for dental claims, to change the billing codes and reimbursements for physician claims, to require payers to provide an explanation of benefits when providers' bills are reduced, to redefine the term "physical medicine," and to repeal in-patient treatment standards. The general authority for these rules, as cited by the department, is SDCL 62-7-8.

A public hearing will be held in Conference Room 1 of the Kneip Building, 700 Governors Drive, Pierre, South Dakota, on February 27, 2002, at 10:30 a.m. Copies of the proposed rules may be obtained from the Department of Labor, Division of Labor and Management, Kneip Building, 700 Governors Drive, Pierre, South Dakota 57501-2291. Written comments may be sent to the Department of Labor at the above address and must be received by March 9, 2002, to be considered. Persons who have special needs for which the department can make arrangements are asked to call (605) 773-3681 before the hearing.

Department of Commerce and Regulation: Division of Insurance: (February 4, 2002) is proposing rules to define the beginning date of a guaranteed issue period when Medicare coverage is terminated, establish standards for rates for new long-term care policies, set

guidelines for long-term care sales, change requirement for notice of transfer to apply to all property casualty lines, and to amend the special enrollment rights for marriage, birth, and adoption so that the prior coverage requirement extends only to special enrollment due to loss of coverage. The general authority for these rules, as cited by the department, is SDCL 58-1-14, 58-1-15, 58-4-1, 58-11-51, 58-11-63, 58-17A-2, 58-17A-6, 58-17A-7, 58-17B-4, 58-17B-8, 58-17B-13.1, 58-17B-15, 58-18-79, and 58-26-30.

A public hearing will be held in Room 413 of the Capitol Building, 500 East Capitol Avenue, Pierre, South Dakota, on February 28, 2002, at 1:00 p.m. Copies of the proposed rules may be obtained from and written comments sent to the Department of Commerce and Regulation, Division of Insurance, 118 West Capitol Avenue, Pierre, South Dakota 57501-2000. Written comments must be received by Wednesday, February 27, 2002, to be considered. Copies of the proposed rules are also available on the Division's web-site at www.state.sd.us/insurance.
