Department of Labor: South Dakota

Retirement System: (March 6, 2006) is proposing to amend rules to comply with federal law in regard to certain purchases of service credit, to establish presumptions in regard to a member's total severance of employment, to amend disability rules in regard to an employer's ability to accommodate a disabled employee, to define "earned income" for disability payment purposes, to identify void ballots in trustee elections, to clarify the administration of certain court orders, and to provide for a right of review of staff decisions. The general authority for these rules, as cited by the board, is SDCL 3-12-58 and 3-12-100.

3-14-2006	Revenue and Regulation: Commission on Gaming	Amend Deadwood Gambling Rules to change Silverado Stud poker to add another hand to the five-card hand payout schedule known as the two-pair-dealt hand and amend check cashing procedures to clarify that licensees need not deposit a check by the next banking day when they have a contractual arrangement with a check processor or check guarantee service; 32 SDR 141.
3-20-2006	Education: Board of Education	Amend rules that will create K-12, K-8, and 7-12 special education certification endorsement programs; require that the unit of credit and letter grade for any high school courses taken in the eighth grade be recorded on high school transcripts, that the unit of credit be included in the credits required for

		high school graduation, and that the letter grade calculated in the high school cumulative grade point average; reinstate a rule that was previously repealed because the rule supported the South Dakota Career Assessment Program (SDCAP), an aptitude and interest assessment that is currently administered to South Dakota eighth- and ninth-grade students; 32 SDR 149.
3-23-2006	Transportation	Amend rules to establish a speed limit on South Dakota Highway 445 (Deadwood Avenue) from Interstate 90 to South Dakota Highway 231 (West Chicago Street) in Rapid City; amend an existing speed zone on US Highway 12 through the city of Big Stone City to extend reduced speed limits to the east and west of the city; establish new speed limits north of Big Stone City along State Highway 109; and amend the Extended Period Permit—Over 80,000 on Interstate Permit from a single trip permit to an extended period permit; 32 SDR 149.
3-30-2006	Labor: Division of Labor and Management	Amend the workers' compensation fee schedule; 32 SDR 149.
4-4-2006	Environment and Natural Resources: Operator Certification Program	Amend rules to modify the experience requirement for a water/wastewater operator that does not have applicable post-high school education in order to become certified as a Class III or IV operator. Applicable post-high school education includes "college or vocational school majoring in engineering, environmental sciences, or related fields"; 32 SDR 135.
