NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council.)

Department of Labor: Electrical Commission: (March 23, 2009) intends to amend rules to require standards for attaining a 501(d) license and for attaining levels of licensure above 501(d); address fee administration for 501(d) active and inactive licensure; document exceptions to the National Electrical Code as approved by the South Dakota Electrical commission; address fee administration for maintenance inspections; address fee administration for wiring permits; and eliminate the requirement for a wiring permit, inspection fee or inspection for modular homes or modular structures exported out of South Dakota. The general authority for these rules, as cited by the commission, is SDCL 36-16-12 and 36-16-30.

A public hearing will be held in Room 412, 4th floor, State Capitol, Pierre, South Dakota, on April 16, 2009, at 10:00 a.m. Copies of the proposed rules may be obtained from and written comments sent to the State Electrical Commission, 308 S. Pierre Street, Pierre, South Dakota 57501. Written comments must be received by April 15, 2009, to be considered. Persons who have special needs for which the commission can make arrangements are asked to call (605) 773-3573 at least 48 hours before the hearing.

Department of Revenue and Regulation: Division of Insurance: (March 27, 2009) intends to amend rules to repeal duplicative authority and to define premium for premium tax reporting purposes. The general authority for these rules, as cited by the division, is

SDCL 10-44-1.1, 58-11-63, and 58-17A-2.

A public hearing will be held in the Main Floor Conference Room, Anderson Building, Pierre, South Dakota, on April 20, 2009, at 10:00 a.m. Paper copies of the proposed rule may be obtained without charge from and written comments sent to the Department of Revenue and Regulation, Division of Insurance, Administrative Rules, 445 E. Department of Social Services: (March 27, 2009) has filed a rule amendment to update the federal poverty level for programs under Title 67. The federal poverty level is set in 74 Fed. Reg. 4,199 (January 23, 2009).

This rule is adopted under the procedure provided in SDCL 1-36-20. This procedure permits adoption of a federally mandated rule without following the procedures set forth in SDCL 1-26-4 to 1-26-6, inclusive.

Department of Social Services: (March 27, 2009) has filed a rule amendment to increase the Supplemental Security Income (SSI) amount.

This rule is adopted under the procedure provided in SDCL 1-36-20. This procedure permits adoption of a federally mandated rule without following the procedures set forth in SDCL 1-26-4 to 1-26-6, inclusive.

Department of Social Services: (March 27, 2009) has filed rule amendments to increase the maximum amount of spousal resources that may be protected under Medicaid when one spouse is receiving institutionalized care and the other spouse remains at home.

This rule is adopted under the procedure provided in SDCL 1-36-20. This procedure permits adoption of a federally mandated rule without following the procedures set forth in SDCL 1-26-4 to 1-26-6, inclusive.
