Department of Health: Division of Health Systems Development and Regulation:

(July 19, 2017) intends to adopt rules to give the department authority to license and regulate community living homes in South Dakota. The general authority for these rules, as cited by the department, is SDCL §§ 34-12-7 and 34-12-13.

A public hearing will be held at the Hayes Building, Robert Hayes Conference Room 107, 600 E. Capitol Ave., Pierre, South Dakota, on August 29, 2017, at 2:00 p.m. Copies of the proposed rules may be obtained without charge from and written comments sent to the Department of Health, Hayes Building, 600 E. <p>7-27-2017</p>	<p>Department of Transportation Amend Highway and Bridge Improvement Plan Requirements rules to state that the format of annual plan updates must substantially conform to the department's guidelines, the annual plan updates may be submitted electronically or by hard copy, the annual plan updates must contain up-to-date information about the five-year project list from the previous year's plan or update, eliminates the deadline of December 16, 2015, which applied to county bridge improvement grant applications considered in 2016, clarify that county grant applicants must submit highway and bridge improvement plans, or plan updates, by October 15 of the calendar year preceding the grant application deadline, clarify that bridge improvement grant recipients must submit highway and bridge improvement plan updates by October 15 of each year, allow counties to make amendments to highway and bridge improvement plans at any time, repeal a rule regarding emergency changes to bridge improvement plans, amend Local Bridge Improvement Grant Requirements rules to replace the reference to an "approved" county highway and bridge improvement plan with an "accepted" county highway and bridge improvement plant, change the deadline to October 30 for the Transportation Commission to consider preliminary engineering grant applications submitted by August 1 of that year, and eliminate the requirement regarding extensions; 44 SDR 9, July 10, 2017.</p>
