NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council)

Department of Human Services: Division of Rehabilitation Services: (September 10, 2001) is proposing rules to provide an appeal and hearing process for interpreters in the event of denial, suspension, or revocation of certification, clarify the minimum number of evaluators necessary on the interpreter review panel, clarify the endorsement process, and increase the fee for the initial evaluation or reexamination for certification. The general authority for these rules, as cited by the department, is SDCL 1-36A-12 and 1-36A-15.

A public hearing will be held in Room 412, Fourth Floor of the State Capitol, 500 East Capitol Avenue, Pierre, South Dakota, on Tuesday, October 2, 2001, at 1:15 p.m. Copies of the proposed rules may be obtained from and written comments sent to Velda Bartel, Administrative Rules Coordinator, Department of Human Services, Hillview Plaza, East Highway 34, c/o 500 East Capitol, Pierre, South Dakota 57501-5070. Department of Social Services: (September 13, 2001) intends to adopt rules to allow the Department to begin paying providers for

diabetes education services provided on behalf of eligible individuals. The general authority for these rules, as cited by the department, is SDCL 28-6-1.
