NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council)

Office of Secretary of State: Board of Elections: (November 2, 2001) is proposing rules to provide additional standards for counting imperfectly marked ballots and for automatic tabulating system recounts, provide specific postal endorsements for certain notices, prescribe the notice for potential duplicate voter registrations, clarify when information may be added to a petition, add an election logo to certain envelopes, broaden the use of recount certificates, provide a recount petition for school and municipal ballot question elections, and simplify voter instructions. The general authority for these rules, as cited by the office, is SDCL 12-1-9, 12-4-35, 12-17B-7, and 12-17B-17.

A public hearing will be held in Room 412, State Capitol, 500 East Capitol, Pierre, South Dakota, on Wednesday, November 28, 2001, at 12:30 p.m. Copies of the proposed rules may be obtained from and written comments sent to the Secretary of State, Election Department, 500 East Capitol, Pierre, South Dakota 57501. Written comments must be received by November 27, 2001, to be considered. This hearing is being held in a physically accessible
