NOTICES OF PROPOSED RULES: (The date in parentheses is the date the rules were filed in the Legislative Research Council)

Department of Agriculture: (December 10, 2001) is proposing rules to change the residency requirement for numerous financial programs to make eligible any applicant who becomes a resident of South Dakota before loan closing and who meets all other requirements of the financing programs. The general authority for these rules, as cited by the department, is SDCL 38-6-8.1.

A public hearing will be held at the South Dakota Department of Agriculture, Foss Building, 523 East Capitol Avenue, Pierre, South Dakota, on Thursday, January 17, 2002, at 1:15 p.m. Copies of the proposed rules may be obtained from and written comments sent to the South Dakota Department of Agriculture, Foss Building, 523 East Capitol Avenue, Pierre, South Dakota 57501. Written comments must be received by January 27, 2002, to be considered. This hearing is being held in a physically accessible place. Persons who have special needs for which the department can make arrangements are asked to call (605) 773-5436 at least forty-eight hours before the hearing.

Department of Transportation: (December 11, 2001) intends to adopt rules to extend the 20 mph speed limits to the north within the town of Platte. The general authority for this rule, as cited by the department, is SDCL 32-25-7.

A public hearing will be held in the Commission Room, Becker-Hansen Building, 700 East Broadway Avenue, Pierre, South Dakota, on

Wednesday, January 24, 2002, at 9:05 a.m. Copies of the proposed rules may be obtained from and written comments sent to Secretary of Transportation, Room 202, Becker-Hansen Building, 700 East Broadway Avenue, Pierre, South Dakota 57501-2586. Written comments must be received by January 23, 2002, to be considered. This hearing is being held in a physically accessible place. Persons who have special needs for which the department can make arrangements are asked to call (605) 773-3265 at least forty-eight hours before the hearing.

Department of Game, Fish and Parks: (December 14, 2001) is proposing rules to amend the spring wild turkey hunting season; modify refuge boundaries in the Spring Creek State Waterfowl Refuge on Lake Oahe; modify the boundaries of the "no wake zone" and repeal the "public swimming zone" on Elm Lake in Brown County at certain times; establish a "no boating zone" at certain times at Helgeson Slough in Clark County; permit the use of spears and bow and arrow to take rough fish throughout the day, including night time, during the summer; allow persons participating in religious activities to use and remove certain vegetation from certain areas of the state park system; and permit licensed deer hunters in the Oahe Downstream Recreation Area to possess uncased firearms and bows during the deer season. The general authority for these rules, as cited by the department, is SDCL 32-3A-1, 41-2-18, 41-2-19, 41-11-5, and 41-17-1.1.

A public hearing will be held at the Ramkota River Center, 920 West Sioux Avenue, Pierre, South Dakota, on Thursday, January 3, 2002, at 2:00 p.m. Copies of the proposed rules may be

Department of Social Services: (December 14, 2001) has proposed a rule amendment according to SDCL 1-36-20. The amendment establishes the parameters under which the Health Care Financing Administration (HCFA) sets the upper limits for multiple source drugs, prohibits a state Medicaid agency from exceeding the upper limits for multiple source drugs established by HCFA, and requires HCFA to publish in Medicaid program instruction the list of multiple source drugs for which upper limits have been established, together with any revisions to that list.

The published federal upper limits are mandatory pricing controls that the state of South Dakota is mandated to adhere to as a condition of participation in the Title XIX (Medicaid) program. These limits must be implemented no later than January 22, 2002.
